Government Institute for Training of Trainers Sector-5, Rohtak

A. About:

Government Institute for Training of Trainers (G.I.T.O.T.) has been set up by the Industrial Training Department, Haryana located at Rohtak and <u>affiliated by Ministry of Skill Development & Entrepreneurship, New Delhi GOI.</u> The demand of qualified instructors is huge as compared to capacity of various instructor training institutes in India. This institute is entrusted with the mission to act as a center for offering quality training programs for instructors to meet the demand of various Industrial Training Institutes (ITI's) at regional and also at national levels. Initially the institute is running CTI course for instructors of Govt. Industrial Training Institutes, for industries sponsored and private candidates under Crafts Instructor Training Scheme of Ministry of Skill development & Entrepreneurship, Govt. of India. The objective of this institute is not only to train and produce systematically trained craft instructors but to conduct need based training programs in the form of 'Tailor Made' programs. The GITOT, Rohtak will have a seating capacity of 240 trainees in the following skill areas under CITS scheme.

- 1. Fitter
- 2. Turner
- 3. Mechanic Motor Vehicle

B. Course Structure:

Craft Instructor Training for Engineering Trades in semester system will be imparted as per the syllabi approved by National Council for Vocational Training (NCVT) for each semester. The complete course of Instructor Training for engineering trades will be delivered in two semesters each of six month duration namely:

- a. <u>FIRST SEMESTER</u> 6 months (Comprising Basic components of trade theory, practical, workshop calculation & science and Engg. Drawing)
- <u>SECOND SEMESTER</u> 6 months (Comprising Advanced Trade theory, practical, Training Methodology and Principles of Teaching)

Training Schedule is to be started from academic session.

C. Mode of Admission:

Admission will be made purely on the basis of merit of Entrance Test held by Ministry of Skill Development & Entrepreneurship, GOI, New Delhi, generally in the month of June every year. Sponsored candidates for Govt. organization may apply to institute for direct Admission through Proper Channel i.e. through state Directorates. Selection of private candidates will be made on merit of all India Entrance Test to be conducted by Ministry of Skill Development & Entrepreneurship, GOI, and New Delhi.

- 1. 25 % of sanction seats are reserved for sponsored candidates.
- 2. First preference will be given to the candidates sponsored by state directorates/Union

 Territories in-charge dealing with Craftsman Training Scheme from the various Govt. ITI's in

 India.
- 3. The next preference will be given to the candidates sponsored by affiliated Pvt. ITI's, Government of India Departments, any other Department of State Government/UT, Public sector Enterprises (Central/State), If seats fall vacant then these will be offered to affiliated ITI's /ITC's, Government of India undertakings and industrial organizations on strictly first come first serve basis. There is no age limit for candidates sponsored by state directorate.
- 4. Private candidates for the rest of 75% vacant seats who apply through the all India Entrance
 Test held by Ministry of Skill Development & Entrepreneurship, GOI, New Delhi.
- 5. Reservation will be made as per Government policy.

D. How to apply:

- 1. State Directors may send nominations of instructor working in Govt. ITI'S directly to the Joint Director of the Institute.
- 2. Private affiliated ITI/ITC instructor & fresh ITI students may apply for entrance test.
- 3. Application form may be available from the website Ministry of Skill Development & Entrepreneurship, GOI, and New Delhi, which is advertised in newspaper.

E. Sponsored Candidates:

- 1. 25 % seats are to be filled by sponsored eligible candidates.
- 2. Candidates who are Matriculate and in-between 18 to 40 years of age & have passed National Trade Certificate (NTC) or National Apprenticeship Certificate (NAC) in the concerned trade or Diploma/degree in relevant branch of Engineering (Appendix A).

H. Examination and Certification:

Final Trade test shall be conducted in the end of every semester in theory and practical subjects.

The successful candidates who have passed both the semesters shall be awarded "Certificate of Proficiency" certificate by National Council of Vocational Training (NCVT), Govt. of India, Ministry of

Skill Development & Entrepreneurship, GOI, and New Delhi. They become eligible for the appointment as Craft Instructors at various Training Institutes. The minimum attendance required for appearing in Examination is 80% and Pass marks 60% in theory as well as practical for getting Craft Instructor Certificate.
